General exclusions: • WLEs with Discontinuation reason of 'Date Entry Error'; and waitlist entries that have been flagged for exclusion and/or pending exclusion and/or confirmed accurate.

ALC Overlapping WLEs	<p>Flags entries with wait times that overlap with another ALC entry for the same patient.</p> <p>Two or more WLEs (open or closed) for the same patient with ALC Wait Time overlap > 1 day;</p> <p>For example, WLE #1: Start Date1 = Designation Date Stop Date1 = Discharged or Discontinuation Date or Current Date (open cases) WLE # 2: Start Date2 = Designation Date Stop Date2 = Discharged or Discontinuation Date or Current Date (open cases) Overlapped when, Start Date 2 is < Stop Date 1</p>	<ul style="list-style-type: none"> • ALC length of stay is zero day for closed cases (including discharged and discontinued cases) • Inpatient service (Rehab, Mental Health or Complex Continuing Care) is the same as the ALC discharge destination (Rehab, Mental Health or Complex Continuing Care) except for Complex Continuing Care at Bloorview Kid Rehab (facility number 939).
ALC Duplicate WLEs	<p>Flags Potential Duplicate WLEs.</p> <p>Two or more ALC WLEs (open or closed) with the same: patient ID, site #, inpatient service, inpatient admission source, inpatient admission date, designation date, discharge determination date, ALC discharge destination, visit number, MRN number, discharge date, recent discontinuation date, recent redesignation date, recent discontinuation reason, patient first name, patient middle name, patient last name, patient birth date, gender, health cared number, version code and death date</p>	<ul style="list-style-type: none"> • ALC length of stay is zero day for closed cases (including discharged and discontinued cases) • Inpatient service (Rehab, Mental Health or Complex Continuing Care) is the same as the ALC discharge destination (Rehab, Mental Health or Complex Continuing Care) except for Complex Continuing Care at Bloorview Kid Rehab (facility number 939).
ALC Waits Longer than 365 Days	<p>Flags open entries with wait times exceeding 365 days.</p> <p>WLE is in open status and ALC wait > 365 days. ALC Wait = (current date - ALC designation date) - total ACE days. Total ACE days = sum of each individual ACE days. ACE days = ALC re-designation - ALC discontinuation date.</p> <p>If the WLE is still open 182 days after a user confirms the data is accurate, the indicator will be reflagged to ensure data accuracy.</p>	None
ALC Same Bed Type	<p>Flags entries where the inpatient service = discharge destination.</p> <p>WLE is in open or closed (discharged and/or discontinued) status and Inpatient Service value = Discharge Destination value, where value = Rehab, Mental Health, CCC except for CCC at facility 939</p>	None
ALC Same Inpatient Service as Discontinuation Reason	<p>Flags entries with an acute inpatient service and a discontinuation reason of Transfer to Acute Care.</p> <p>WLE is in closed status, Inpatient Service = 'Surgical, Non Surgical or Intensive Care' and Discontinuation Reason = 'Transfer to Acute'.</p>	None
