Hospital Requested Enhancement	 CEDIS-specific assessment panel The subjective notes field has been enhanced to display recommended assessment reminders for nurses when specific CEDIS complaints are selected. A new panel will appear for these specific CEDIS complaints to facilitate nurse documentation. An 'Add to Subjective Notes' button is provided to merge the information entered in the assessments into the existing subjective notes field. The nurse can still modify any notes entered within the subjective note. New pop-up notifications have been added to support the CEDIS-specific assessment panel. Triage nurses will be alerted if they do not merge or cancel any information entered in this panel prior to: changing the CEDIS complaint. Nurses have the option to save or discard the notes entered for the first CEDIS complaint before changing the complaint. selecting 'I'm Done Triage'. Nurses have the option to keep or discard the notes and continue saving or return to their triage.
